14-DAY ISRAEL BIBLICAL STUDY PROGRAM REGISTRATION AND RELEASE OF LIABILITY FORM

FOR AND IN CONSIDERATION of being permitted by BIBLE WORLD SEMINARS and the C.S. Lewis Institute to participate in the March 14 - 28, 2009, Israel Biblical Study Program, the undersigned Participant, being of legal age, hereby agrees to the following terms and conditions:

Cancellation and Refund Policy - Since air tickets are not refundable once purchased, any ticket refund will be determined by the airline policy. **Please note that Bible World Seminars cannot control cancellations, changes and cost due to medical problems, adverse political activity, strikes, severe weather or adjustments in the announced airline fees. No refund is possible once any payments are made for airline and overseas services (except through approved travel insurance coverage or in accordance to airline policy) regardless of any unforeseen situations.** Travel and health insurance are the sole responsibility of each participant. All participants must: 1) have an insurance policy which will cover them while in Israel (contact your carrier to be certain this is the case or contact your carrier to be certain this is the case); or 2) bring contingency funds (cash or credit card) in case an emergency should arise so that they can pay in full and later file a claim for reimbursement to their insurance company.

Waiver of Responsibility - Enrollment in this program indicates that each person: 1) Fully understands the risk and physical demands of this program and personally accepts sole responsibility; 2) Fully understands the study program may be canceled or price may change due to political or other factors beyond the control of BWS and thereby holds Dr. James C. Martin, Bible World Seminars staff, the C.S. Lewis Institute, its staff and all group sponsors blameless in the event of personal injury, cancellations, changes in travel program, schedule and/or adjustments in announced fees; 3) Releases Dr. James C. Martin, Bible World Seminars staff, the C.S. Lewis Institute, its staff and all group sponsors from claims of any nature incurred while on this program; 4) Agrees that in the event of war, strike, emergency or cancellation, any refund will be determined by the airline carriers and agent(s) in the USA, Egypt and Israel; 5) Fully understands that neither Dr. James C. Martin, the C.S. Lewis Institute, its staff or any group sponsors are providing any medical services or insurance for the study program and that each Participant will be solely responsible for the expense of any medical treatment incurred due to injury or illness; 6) Authorizes medical treatment, including hospitalization (at their own expense) if such is deemed necessary by a medical doctor and returned home for medical treatment (also at their own expense) if circumstances warrant; 7) Fully understands that his/her participation in the study program has the approval of any spouse, children, parents and/or guardian and that they agree to be bound by the terms and conditions of this Release; 8) Releases and holds harmless BWS, Dr. James C. Martin, the C.S. Lewis Institute, its staff and all group sponsors including any affiliate, sponsoring person(s) or institutions involved in this program from any liability for any delays, injury or death incurred during the study program and solely assumes all rights and responsibilities for participating in this program.

Program costs include roundtrip airline tickets from Washington, DC to Israel, breakfast and dinner, entrance fees, housing, overseas land transportation, taxes, tips, study materials and teaching fees. Not included are personal items, lunches, beverages at meals (with the exception of juice, tea and coffee at breakfast), “single supplement” fee of \$500 if required, medical insurance or fees due to delays, cancellations, emergencies or any unforeseen expense outside of this program.
